

West Virginia School Based Health Center Staff and School Nurses are invited to a free 3-part webinar series on Screening, Brief Intervention and Referral to Treatment (SBIRT)— Thursday, February 14, 2013, as well as February 28 and March 14, from 2:30-3:30 p.m

Do you need substance abuse training to meet your licensure requirements for Senate Bill 437 or are you interested in learning more? If so, join us for a series of WebEx's on **Screening, Brief Intervention and Referral to Treatment (SBIRT), Drug Diversion, and Best Practice Guidelines Regarding Controlled Substances.** Participants will learn about substance misuse and the basic components of SBIRT as an evidenced based model during the first SBIRT WebEx.

Recently the RN news magazine provided information on newly mandated 3 hours of continuing education related to substance misuse. This requirement is part of the Governor's Bill on Substance Abuse - Senate Bill 437. The deadline for the 3 hours of CE is October 31, 2013.

This training is geared towards school nurses and school-based health center staff and will be offered only via WebEx (no conference call lines will be available). **The Webinar is FREE but you must register in advance**. We are limited to the first 100 WebEx participants, so please **register early** and try to plan for group access when able. The Webinars will be recorded for scheduling convenience. Nurses are encouraged to become fully trained in SBIRT with the 3 webinars to fully meet the WV RN Board requirements for CEUs. Yes, this means you will have three nursing contact hours towards substance abuse, but the full SBIRT training is a true value for nurses working within the school setting.

# PART 1 – FEBRUARY 14, 2:30-3:30 Learning Objectives - Participants will:

- 1. The attendee will learn the prevalence of substance misuse Nationally and in West Virginia for school aged youth.
- 2. The attendee will learn the basic component of SBIRT as an evidenced based model.

# PART 2 – FEBRUARY 28, 2:30-3:30 Learning Objectives - Participants will:

1. The attendee will learn the background of the Transtheoretical Model of Change and the application to Substance misuse.

2. The attendee will learn interviewing basics designed to reduce resistance and promote disclosure.

#### PART 3 – MARCH 14, 2:30-3:30 Learning Objectives - Participants will:

- 1. The attendee will learn "best practices" related to Patient Evaluation/ risk assessment and compliance with state/federal laws related to the prescribing of controlled substances.
- 2. The attendee will learn core principles related to drug diversion, specifically epidemiology and treatment of chronic pain including toxicities and drug interactions.
